Should any final action, decision or vote be required in the opinion of the Civil Service Commission with regard to any item discussed during the closed meeting, then such final action, decision or vote shall be made during the open meeting covered by this notice upon the reconvening of the public meeting pursuant to Section 551.102 Government Code V.T.C.S.

In compliance with Section 551.041 et seq. Of the Texas Government Code V.T.C.S. (Open Meetings Act), notice is hereby given that the Civil Service Commission will meet at the time and place indicated to consider and act upon the following:

2. Roll call and possible action, if any, excusing any absent member of the Civil Service Commission.

4. Consideration and action, if any, approving and accepting the raw and final scores from the promotional exam administered May 27, 2015 for Lieutenant in the police department.

Pursuant to Section 551.074, the Commission may convene in a closed, non-public meeting to discuss any matters related to personnel matters to deliberate the **appointment, employment, evaluation, reassignment, duties and discipline or dismissal of a public officer or employee and to hear any complaints or charges against an officer or employee.** The Commission and its attorney may also discuss such issues with the appropriate staff including members so as to obtain necessary and relevant information so that such discussion is informative and developed.

The Commission and its attorney may also discuss such issues with the appropriate staff so as to obtain necessary and relevant information so that such discussion is informative and developed.

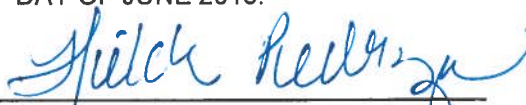
NOTICE OF ASSISTANCE AT THE PUBLIC MEETING
