Mayor Palacios called the meeting to order at 12:52 p.m. Roll Call established a quorum.

Ed Arjona led in the pledge of allegiance and said the prayer.

Mayor Palacios asked for a moment of silence for the passing of Ruben Flores, brother of Judge Bobby Flores.

Mayor Palacios read Proclamation proclaiming May 19-23, 2014 as National Public Works Week and presented proclamation to Roy Garcia and Rene Saenz.

Roy Garcia, Director of Public Works, thanked the Board for the proclamation and recognized all the men and women in the field of maintenance, education, construction and infrastructure services known as Public Works.
