Introduction

In accordance with Governmental Accounting Standards Board Statement No. 68, *Accounting and Financial Reporting for Pensions - an amendment of GASB Statement No. 27*, employers (TMRS participating cities) are required to recognize their specific pension amounts, which include net pension liability (NPL), deferred outflows and inflows of resources, and pension expense. The total pension liability (actuarially determined pension benefits) less the value of the assets available in the TMRS Plan to pay the pension benefits (Fiduciary Net Position, or FNP) results in the NPL.

The **Schedule of Changes in Fiduciary Net Position (By Participating City)** includes the additions and deductions made to each city's Benefit Accumulation Fund; TMRS is also required to allocate the remaining assets held in trust to each participating city. The FNP, or "assets" allocated to each city, are used against its total pension liability to determine the city's net pension liability.

TMRS has also completed a SOC-1 Type 2 audit on the controls over the calculation and allocation of additions and deductions to the city accounts. The SOC-1 Type 2 Audit Report can be found on the TMRS City Portal.

Report on the Schedule

We have audited the fiduciary net position as of December 31, 2020, and the changes in fiduciary net position for the year then ended, included in the accompanying schedule of changes in fiduciary net position by participating city (Schedule) of the Texas Municipal Retirement System (TMRS) and the related notes.

Management's Responsibility for the Schedule

Management is responsible for the preparation and fair presentation of the Schedule in accordance with accounting principles generally accepted in the United States of America; this includes the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of the Schedule that is free from material misstatement, whether due to fraud or error.

Auditors' Responsibility

Our responsibility is to express an opinion on the fiduciary net position and the changes in fiduciary net position included in the Schedule based on our audit. We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Those standards require that we plan and perform the audit to obtain reasonable assurance about whether the fiduciary net position and the changes in fiduciary net position included in the Schedule are free from material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the Schedule. The procedures selected depend on the auditors' judgment, including the assessment of the risks of material misstatement of the fiduciary net position and the changes in fiduciary net position included in the Schedule, whether due to fraud or error. In making those risk assessments, the auditor considers internal control relevant to the entity's preparation and fair presentation of fiduciary net position and changes in fiduciary net position included in the Schedule in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the entity's internal control. Accordingly, we express no such opinion. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluating the overall presentation of the fiduciary net position and the changes in fiduciary net position included in the Schedule.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

In our opinion, the Schedule referred to above presents fairly, in all material respects, the fiduciary net position of the Texas Municipal Retirement System as of December 31, 2020, and the respective changes in fiduciary net position for the year then ended in accordance with accounting principles generally accepted in the United States of America.

We do not express an opinion on the fiduciary net position or changes in fiduciary net position of each individual employer.

Notes to Schedule of Changes in Fiduciary Net Position (by Participating City)

Background and Reporting Entity

The Texas Municipal Retirement System (TMRS) is a statewide public retirement plan created by the State of Texas and administered in accordance with the Texas Municipal Retirement System Act, Subtitle G, Title 8, Texas Government Code (the TMRS Act) for the benefit of the employees of Texas participating cities. For governmental accounting purposes, TMRS is considered an agent multiple-employer public employee retirement system, administering a defined benefit cash-balance plan. TMRS issues a publicly available Comprehensive Annual Financial Report (Report), including financial statements, notes and required supplementary information, which can be obtained at tmrs.com. Pension Trust Fund Description

Benefits. At retirement, the Member's retirement benefits are calculated based on the sum of the Member's contributions, with interest, and the city-financed monetary credits, with interest. City-financed monetary credits are composed of three sources: Prior Service Credit, Current Service Credit and Updated Service Credit. The retiring Member may select one of seven monthly benefit payment options: the retiree life only option; one of three survivor lifetime options; or one of three guaranteed term options. Members may also choose to receive a portion of their benefit as a lump sum distribution. A participating city may elect to increase the monthly benefit payment of its retirees annually, either on an ad hoc or a repeating basis, effective January 1.

Contributions. TMRS provides mandatory and optional plan benefit design features that participating cities adopt by ordinance, which may be amended by a city on a prospective basis. Member contribution rates, adopted by a participating city, may be either 5%, 6% or 7% of the Member's total compensation. A participating city must pay its required city contribution rate, which is determined annually by TMRS' external actuary, using the Entry Age Normal (EAN) actuarial cost method. Contributions are required to be deposited with TMRS monthly by the participating cities. There is a one-year delay between the actuarial valuation that serves as the basis for a city's contribution rate and the calendar year when the rate goes into effect.

Basis of Presentation and Accounting

The Schedule of Changes in Fiduciary Net Position by Participating City (the Schedule) has been prepared on the accrual basis of accounting based on the provisions of Governmental Accounting Standards Board Statement No. 67, *Financial Reporting for Pensions Plans - An Amendment of GASB Statement No. 25* (GASB 67). A separate row has been included for each participating city's separate account.

Investment income (allocation). Net investment income credited to each city is shown separately in the attached Schedule and represents the interest credit to the city's Benefit Accumulation Fund (BAF) as authorized by the Board of Trustees. The other net investment income is allocated to each city based on the city's beginning balance of Fiduciary Net Position.

Contributions. The city contributions and Member contributions for each participating city are recognized in the period that the city reports compensation of its employees, which is when the contributions are legally due.

Benefit payments. Retirement benefits are recorded when payable in accordance with TMRS' plan terms. Inactive Member refunds are recorded and paid upon receipt of an approved refund application.

Administrative expenses and other (allocation). The administrative expenses and other amounts are allocated to each city based on the city's beginning balance of Fiduciary Net Position.

Fiduciary Net Position. This represents the total assets less liabilities measured in accordance with GASB 67. The individual elements of the Pension Trust Fund as a whole are included in the Statement of Fiduciary Net Position in TMRS' separately issued Comprehensive Annual Financial Report.

Use of estimates. Management of TMRS has made some estimates and assumptions relating to the reporting in the Schedule in conformity with U.S. generally accepted accounting principles (GAAP). Actual results could differ from those estimates.
