Should any final action, decision or vote be required in the opinion of the Civil Service Commission with regard to any item discussed during the closed meeting, then such final action, decision or vote shall be made during the open meeting covered by this notice upon the reconvening of the public meeting pursuant to Section 551.102 Government Code V.T.C.S.

In compliance with Section 551.041 et seq. Of the Texas Government Code V.T.C.S. (Open Meetings Act), notice is hereby given that the Civil Service Commission will meet at the time and place indicated to consider and act upon the following:

1. Call meeting to order.
2. Roll call and possible action, if any, excusing any absent member of the Civil Service Commission.
3. Election of Officers - Chairperson and Vice-Chairperson
4. Consideration and action, if any, authorizing an entry level exam be administered for fire fighter.
5. Consideration and action, if any, accepting and approving the raw and final scores from entry level exam administered January 31, 2015 for peace officer.
6. Consideration and action, if any, accepting and approving the certified eligibility list for peace officer from entry level exam administered January 31, 2015.
7. Consideration and action, if any, accepting and approving an amended certified eligibility list for peace officer as a result of the physical agility phase administered Sunday, February 8, 2015.

Pursuant to Section 551.074, the Commission may convene in a closed, non-public meeting to discuss any matters related to personnel matters to deliberate the **appointment, employment, evaluation, reassignment, duties and discipline or dismissal of a public officer or employee and to hear any complaints or charges against an officer or employee**. The Commission and its attorney may also discuss such issues with the appropriate staff including members so as to obtain necessary and relevant information so that such discussion is informative and developed.

The Commission and its attorney may also discuss such issues with the appropriate staff so as to obtain necessary and relevant information so that such discussion is informative and developed.
