Houston Street, Suite 347, San Antonio, Texas 78205, (210) 475-6800 by August 15, 2014. HUD will review the One-year Action Plan and is expected to approve the plan by October 15, 2014.

The City of Pharr is soliciting public comments during a 30-day Comment Period from March 6, 2014 through April 4, 2014 on the proposed Action Plan for program year 2014.
