In compliance with Section 551.041 et seq. Of the Texas Government Code V.T.C.S. (Open Meetings Act), notice is hereby given that the Civil Service Commission will meet at the time and place indicated to consider and act upon the following:

2. Roll call and possible action, if any, excusing any absent member of the Civil Service Commission.

4. Consideration and action, if any, approving and accepting the raw and final scores from the entry level exam administered on Saturday, April 18, 2015 for fire fighter.

Pursuant to Section 551.074, the Commission may convene in a closed, non-public meeting to discuss any matters related to personnel matters to deliberate the **appointment, employment, evaluation, reassignment, duties and discipline or dismissal of a public officer or employee and to hear any complaints or charges against an officer or employee**. The Commission and its attorney may also discuss such issues with the appropriate staff including members so as to obtain necessary and relevant information so that such discussion is informative and developed.

The Commission and its attorney may also discuss such issues with the appropriate staff so as to obtain necessary and relevant information so that such discussion is informative and developed.
