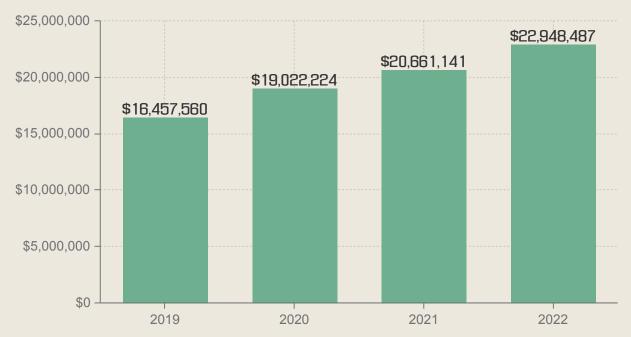

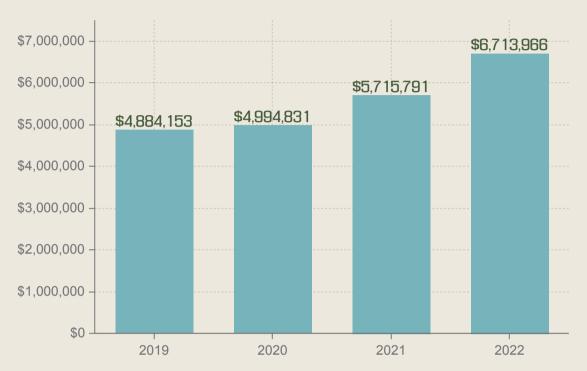


#### Property Tax Collections as of February (5th Month of Collections)

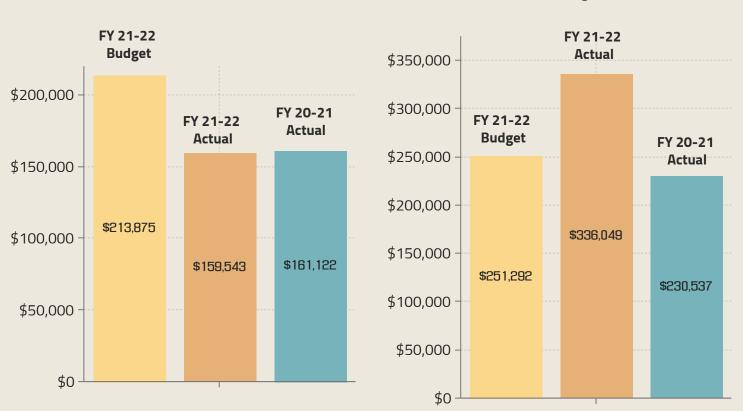

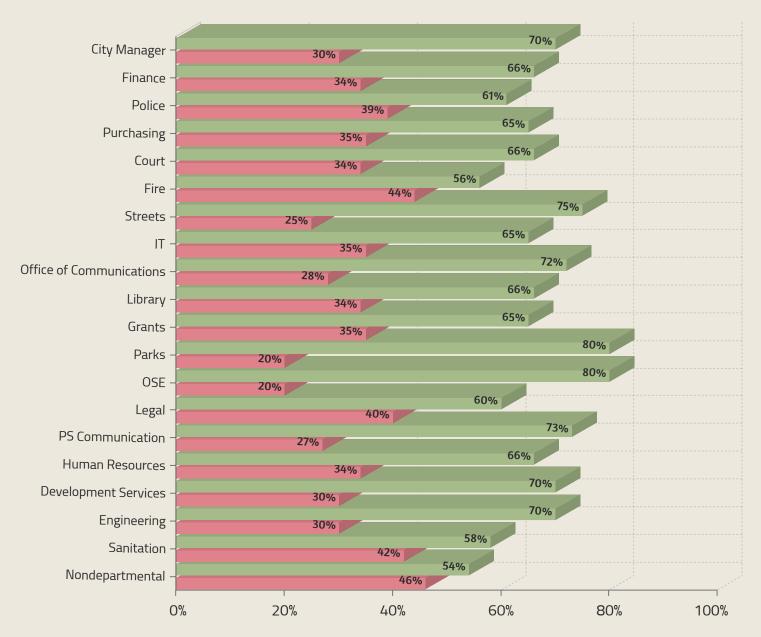

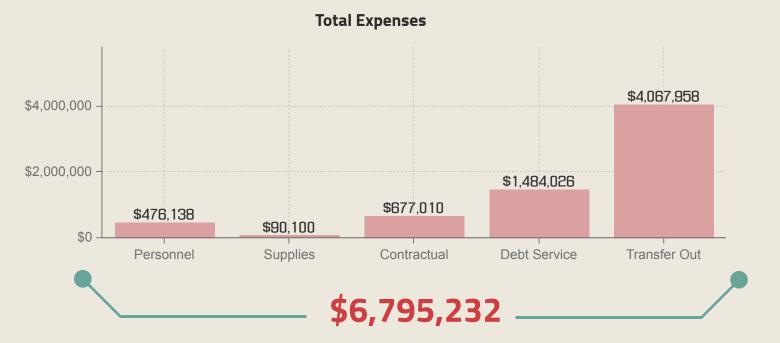

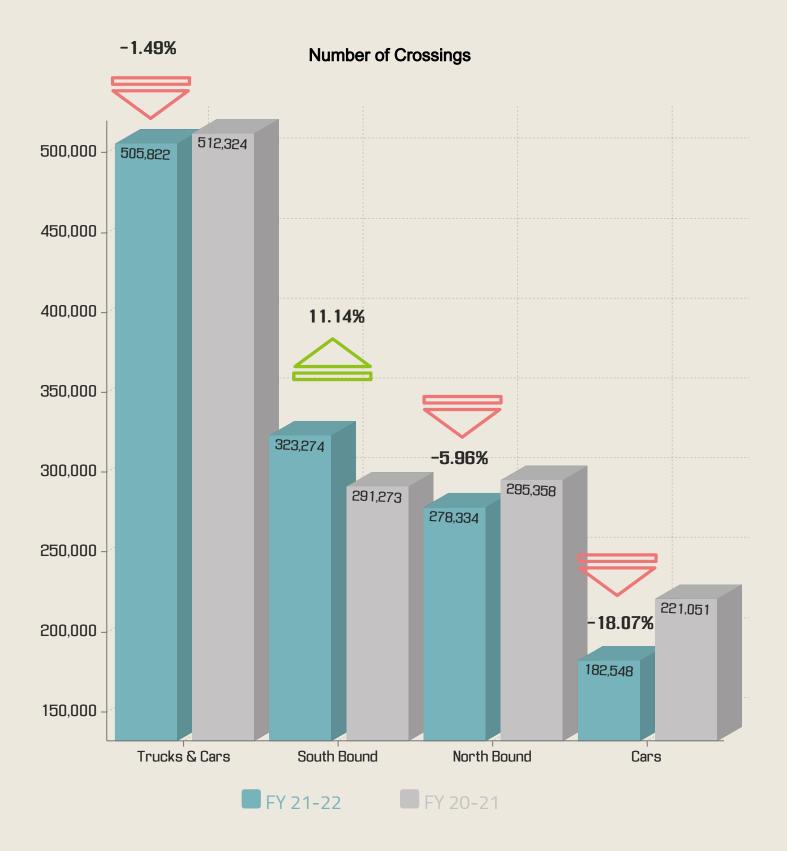

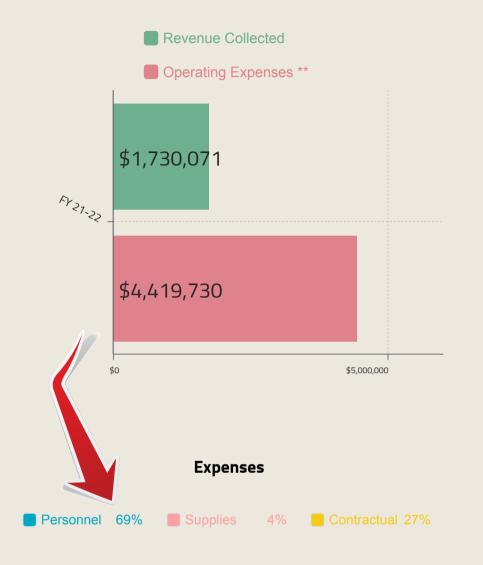

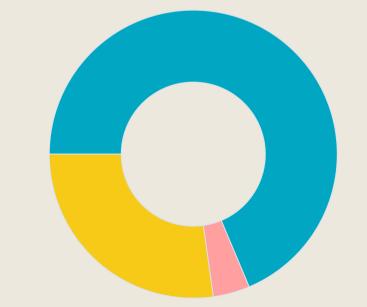
