### GUIDELINES:

2. Application must be approved prior to delivery of bin and will be scheduled on a first come first serve basis.
3. Request date for cleanup must be submitted at least two (2) weeks in advance.
4. Must have the enlisted participation of at least ten (10) neighbors within the subdivision (request form must be submitted with application) or if there is a demonstrated need as approved by the Development Services director or designee.

### PROHIBITED ITEMS:

Household hazardous waste consists of items such as anti-freeze, solvents, brake fluid, transmission fluid, batteries, cleaning solvent, polishes, oven cleaner, pool chemicals, paint, paint thinner, paint stripper, spray paint, weed killer, pesticides, insecticides, sprays, dusts, poisons, gas, motor oil and filters.
