### CITY OF PHARR NOTICE OF FINAL PUBLIC REVIEW OF A PROPOSAL TO SUPPORT ACTIVITY IN FLOOD ZONE "B" 500-YEAR FLOODPLAIN

To: All interested agencies, groups, and individuals

This is to give notice that City of Pharr has conducted an evaluation as required by Executive Order 11988, in accordance with HUD regulations at 24 CFR 55.20 Subpart C: Procedures for making determinations on floodplain management, to determine the potential affect that its activities in the floodplain and wetlands will have on the human environment for City of Pharr **Work Plan FY 2024-2025**. The following activities are being considered:

#### **2024-2025 EMERGENCY REPAIR PROGRAM**

**Minor repairs will be completed in the interior of the home located at 7206 S. Laurel, Pharr, Texas 78577**

There are three primary purposes for this notice. First, people who may be affected by activities in floodplains and those who have interest in the protection of the natural environment should be given an opportunity to express their concerns and provide information about these areas. Second, an adequate public notice program can be an important public educational tool. The dissemination of information about floodplains can facilitate and enhance Federal efforts to reduce the risks associated with the occupancy and modification of the special areas. Third, as a matter of fairness, when the Federal government determines it will participate in actions taking place in floodplains, it must inform those who may be put at a greater or continued risk.
